



# OSHA Auditing: Federal Compliance Guide: Construction

#### new and noteworthy

• **OSHA Final Rule for Beryllium:** The U.S. Occupational Safety and Health Administration (OSHA) has published a final rule revising the beryllium standard for the construction industry. The changes are designed to clarify the standard, simplify and/or improve compliance, and align with the general industry standard. Enforcement of the beryllium standard in construction has been stayed for several years, with the exception of the revised exposure limit. This revised final rule becomes effective September 30, 2020.

A new rulebook will be added to Module Z Toxic and Hazardous Substances of this guide with the next release to cover the requirements of the beryllium standard. - Module C General Safety and Health: Section 1 was reviewed and revised for consistency and clarity.
- Module D1 Occupational Exposures and Environmental Controls Part A Facilities: Sections
  1 and 2 were reviewed and revised to update information about standard interpretations, and for
  consistency and clarity.
- **Module D3 Process Safety Management:** The summary notes at the beginning of the rulebook were reviewed and revised to update information about standard interpretations.
- Module F Fire Protection: All sections of the rulebook were reviewed and revised to delete obsolete terminology related to flammable liquid classes.

- OSHA Instruction for New Silica Compliance Directive: OSHA has issued an "OSHA Instruction" (Directive Number: CPL 02-02-080) on the subject of Inspection Procedures for the Respirable Crystalline Silica Standards. The new directive provides OSHA compliance safety and health officers with guidance on how to enforce the requirements of the silica standards, and it can also assist employers in achieving compliance.
