



## Environmental Auditing: Air Quality Management in Santa Barbara

### new & noteworthy

- **Annual Reports:** Facilities operating under Santa Barbara County Air Pollution Control District (SBCAPCD) permits or exemptions are required to submit annual reports by March 1 of each year for the previous year. SBCAPCD has annual report forms available for the following types of businesses: Bulk Plants, Gas Stations, Surface Coating, Solvent Use, Dry Cleaning (Perc), Dry Cleaning (Non-Perc), Fiberglassing, Autobody Shops, Degreasing Operations, Concrete Batch Plants, Sand, Rock/Gravel Operations, Boilers and Steam Generators, Diesel-Fired Emergency/Standby Engines and Wineries. If a facility did not operate during a calendar year, it must notify SBCAPCD of non-operation, in writing, including the company name, address, phone number, facility number, and permit number(s).

### did you know?

- **Greenhouse Gas (GHG) Reduction Strategies:** SBCAPCD has investigated several different strategies to create greenhouse gas (GHG) reductions and has developed a spreadsheet to provide details on each measure identified, including estimates of potential costs and benefits. Some of the strategy documents that have been identified so far include rebates for zero-emission vehicles, expanding battery-electric and fuel-cell electric vehicle infrastructure, planting urban forests, renewable gas trucks, and retrofitting buildings for energy efficiency, renewable energy, and battery storage.
